Book Manuscript

“Monopoly Politics: Local Governments Plight to Survive Emergencies” *Manuscript in Progress*
State’s centralization of local power has been a tactic for sustaining power for nearly 3 decades; however, in the last decade we have seen more state governments intervene as a way to assist in navigating financial distress. Using seventeen years of survey data, individual voter files, census data, budget data and qualitative interviews, this manuscript tracks the ways that financially distress cities shift and what the impact is on the residents in these cities. With Michigan as a case for centralizing power, the project contends with the political and social norms contested to reach financial solvency.

“Broke’n’ Cities: Understanding Racial Domination in Urban Budgeting”
Urban budgeting has taken several forms over the last half century as the population has shifted in the city center. Given the shift in the way cities are budgeting, this paper analyses the ways that city budgets reinforce articulations of domination. The paper uses the ways that some cities are able to leverage partnership and other are forced to spend cash as a point of contention in articulating racial dynamics in the sustainability of urban cities.

“You Still Live There: Limitations of the Social Welfare Policy in Poverty Irradiation”
Using Panel Study on Income Dynamics (PSID) to answer the question: How effective is social welfare policy in eradicating poverty? This paper analyzes the socioeconomic and political climates surrounding housing policies in Oakland and Detroit in order to better understand where the social policy falls short and what it ignores.

“Tear Down to Build: Abolition Possibilities for Urban Budgets”
“This framework prioritizes concepts of democratic engagement, energy and environmental justice, and fiscal responsibility while holding at the center the most marginalized groups in the community. The assumption is that while institutions are inherently racist, as they rebuild the institution is able to build anew with racial justice at the core. To test the viability of this framework, we examine it within the city of Detroit after undergoing Chapter IX Bankruptcy.”

“Data Transparency and Community Development” w/ Carol G. Flores
In the aftermath of the COVID-19 pandemic, scholars, practitioners, and public administrators have been pushed to be transparent with data and outcomes from the various programs and initiatives. With full data transparency, we can see the fissures in the political, social, health, and economic systems to program toward meaningful changes. This essay considers the limitation of health research that is Eurocentric and avoids problems in the systems that create circumstances causing state violence.
